## WORLD ALLIANCE OF PITUITARY ORGANIZATIONS - WAPO 2022 ACTIVITY REPORT

### INTRODUCTION

WAPO 2022 activities were in the first couple of months still influenced by Covid-19. It impacted the Global Summit, which we had to postpone from April to June 2022. And still then, most meetings were virtual, although it started to change later in 2022 to more face-to-face meetings.

The WAPO Global Summit was a great moment when we could meet each other again after 3 years, with new and old contacts within the pituitary community. Also the Ukraine pituitary patient organization was present with 2 representatives; a unique moment related to the circumstances in their country. After suggestion during the AGM discussions on June 5<sup>th</sup> – the Board accepted to set up a committee 'Transition of Care for Young Adults' to include and focus on young adults (14+ years) in 2023.

And last but not least, we have to inform you that several board members have decided to step down, due to a new position or workload in combination with their daily activities.

We will certainly miss them and thank them for all support in 2022.

### WAPO Board activities

## OPERATIONS

### Finances

The WAPO Finance Committee consists of Muriël Marks, Clive Deverson and support of Angeliki Eleftheriou. An external, independent bookkeeper JB Advies (Netherlands) is available for questions and prepared the quarterly financial overviews and the Annual Finance Overview.

During the AGM of June 5, 2022 the WAPO Board of Directors were granted '**APPROVAL**' for 'All WAPO 2021 Activities as well as 2021 Finances'.

In 2022, the annual WAPO Membership Fee of €35 was invoiced again. However, several patient organizations were not able to pay for the fee and banking costs, which WAPO waived for them.

Several project (extern) activities generated income in 2022, which WAPO used to support patient advocacies who were in need of finances to organize an awareness campaign, and WAPO paid 5 times membership fees of patient organizations who couldn't afford in 2022.

## IT

From August 2019 onwards WAPO works with the Dutch IT services company 'Kwaaijongens', specialized in 'WordPress' websites and M365 support via a partner company 'Linternet'.

Mid 2022 the WAPO Board decided to improve the quality of the website, and build a new website in WordPress, incl. a Webinar/Information Library and a 'Health & Exercises Information' page. Due to workload, the release is now scheduled for January 2023.

All content will be available in open access. Patient organizations, medical advisors and third parties are invited to share information, brochures/leaflets, also in other languages, which WAPO will add in the disease section, so people living with the condition will be able to upload the information.

## Creative Designs

Since 2018 WAPO collaborates with the company El Cuore in Argentina.

In 2022, El Cuore has supported WAPO with designs for the WAPO 2022 Webinar Series, the WAPO Summit, logo for the Global Café sessions and Awareness Campaigns.

## WAPO ACTIVITIES IN 2022

### SUMMIT

In 2022 it was finally possible to organize a live WAPO Summit, the first one since 2019, where patient advocates could meet and discuss in person again!

Although we had to postpone the Summit of April 1-3, 2022 to June 3-5, supported by the flexibility of the hotel and Lumanity and interpreters, the number of registrations was still high. All speakers reconfirmed their interest to be present at this new date. Due to travel- and covid restrictions as well as lock down, a large number of patient advocates were not able to participate. With a lower number of patient advocates incl. many new faces, we held a great and informative Summit 2022. The WAPO Board made it possible for the Ukraine delegation to participate 'live' during the Summit program.

During the Summit the 'WAPO International Recipe Book' was launched and handed out to all participants and speakers.

Presentation recordings will be shared on the Library of the new WAPO website.

The Summit was made possible with support of Ipsen, Novartis, Recordati Rare Diseases, Pfizer, HRA Pharma Rare Diseases, Camurus and Crinetics.



#### Acromegaly Awareness campaign – November 1 2022

The 2022 Awareness Campaign included informative posters, which were shared in many countries. At least 11 Patient Organizations and companies reshared the campaign with their logo and/or translated versions e.g. Acromegaly Community Inc., CSRF, ABAB Bulgaria, Pituitary Alliance Greece, Rare Diseases International, COR2ED, International Society of Endocrinology, IPSEN, Camurus, and more.



#### **DATA & MAPPING**

In 2022 the WAPO Board decided to organize another Mapping project in 2023/2024 (Q4/Q1). During the Summit 2022, Sandra Mesri presented on the Mapping Project and emphasized on the importance to learn about the issues patient communities meet. With this knowledge, WAPO can support all organizations in a better way.

#### **EXTERNAL PROJECTS**

WAPO participated in 2022 in several external projects, organized by other stakeholders. Due to confidentiality regulations, we cannot share the projects here.

#### **WAPO PARTNERS AND MEMBERSHIPS**

WAPO is always looking for value creating partnerships with which parties we can support patient organizations and their members. In 2022 the number of external activities was lower than 2021. Many conferences were still online.

#### **ADRENALNET – ADRENALS.EU**

AdrenalNET is an online community for adrenal diseases, based in the Netherlands, mainly focusing and collaborating with European patient organizations. WAPO follows activities of AdrenalNET and AdrenalNET's coordinator Johan Beun presented in a webinar on November 17<sup>th</sup> regarding a labor project in the Netherlands.

### **European Society of Endocrinology (ESE) / European Congress of Endocrinology (ECE)**

Since January 2022, WAPO has an 'Affiliate Patient Organization' Membership of ESE, for which we are very proud.

In May, ECE 2022 was organized in Milano, Italy. Due to illness of Muriël Marks, Sheila Khawaja participated alone. Sheila met interesting parties to collaborate with in near future. ECE 2022 provided patient advocates with a proper stand in the 'Patient Zone'. During ECE 2022 also Hormone Day was launched.

During a separate meeting for patient advocates, a new ESE Patient Advisory Board was announced, for which organizations could candidate. WAPO was one of the candidates, but was not elected.

During Pituitary Month 2022, the WAPO Awareness poster was shared by ESE.

### **EURORDIS**

Eurordis strengthens the patient voice and shapes research, policies and patient services.

Interesting news or webinars are shared with WAPO members through WAPO social media, e.g. the training courses. Eurordis also shared several WAPO webinar announcements in 2022.

### **European Patients' Forum**

The European Patient's Forum (EPF) is an umbrella patient advocacy in Europe, an intermediary between the patient community and EU policymakers, by providing a cross-disease perspective based on issues regarding chronic conditions.

Since 2022 WAPO is a Full Member, we receive interesting news and invitations for webinars and online meetings. EPF also reshared WAPO webinar announcements.

'Data Saves Lives' Bootcamp (October 10-11, Prague, Czech Republic): A 2-day brainstorming event on the concepts of the use of patient's data, how to protect it and how to make the best use of it. The selection committee selected 12 patient group representatives, and Sheila Khawaja was among the selected.

### **FindMeCure**

FindMeCure is an organization which links the clinical research industry and people looking for a new, alternative treatment via Clinical Trials. WAPO and FindMeCure are partners since 2017.

On January 16, WAPO spoke with FindmeCure on the topic 'What is the role and the challenges of a patient advocate?'. The outcomes did support FindMeCure better in their focus on a more holistic approach to rare, chronic diseases in their 'Medication Hub', which was by then only accessible for industry. The project is finished and visible on their website.

### **Federation of International Nurses in Endocrinology (F.I.N.E)**

WAPO is a member of F.I.N.E. since 2018 and collaborating with Christine Yedinak in several projects, e.g. 'adrenal insufficiency in covid era' as well as the following:

On behalf of F.I.N.E., Chris Yedinak found funding and a company to make a series of animated videos with pituitary disease related information, as well as accompanying medical texts for the new WAPO website. This work is highly appreciated by WAPO, and we especially wish to thank Chris Yedinak for all effort and time she put in the series! The animated video's were also discussed during the Summit, and the audience was very enthusiast.

F.I.N.E. also reshared the 2022 webinar announcements.

### **GAFPA (Global access for Patient Advocacy)**

Sandra Mesri (Argentina) is an active member of the Academy since 2018.

The membership of GafPA is only for patient advocacy leaders, and upon personal invitation.

### **International Alliance of Patient Organizations**

Since 2021, WAPO is officially accepted as a full member of IAPO, which we think is an organization which completes the WAPO activities.

### **Latin Patient Academy (LAPA)**

Sandra Mesri (Argentina) is an active member of the Academy since 2019.

### **Patient Focused Medicines Development – PFMD**

WAPO is a partner of PFMD since 2017 and is actively represented by Sheila Khawaja in various workgroups, e.g. Patient engagement strategic advisory board (SAB).

### **Pituitary World News**

The Pituitary World News representative JD Faccinetti is a WAPO Board member since 2019.

### **International Society of Endocrinology (ISE)**

Since 2019 WAPO is collaborating with ISE on several occasions, e.g. webinars.

For Rare Disease Day, ISE organized a webinar titled ‘Pituitary disorders through the eyes of three different experts in various phases or aspects’ in which Sheila Khawaja participated in a panel discussion with Dr. Susan Webb and Ass.Prof. Christine Yedinak. ISE was also present at the WAPO Summit 2022, and invited a speaker on their behalf, Nienke Biermasz (LUMC, Netherlands).

### **Rare Diseases International**

RDI is the global alliance of people living with a rare disease of all nationalities across all rare diseases, and related to EURORDIS. Since 2019 WAPO has a full membership. In 2022 we participated in several webinars and RDI reshared the WAPO Pituitary Month campaigns.

### **World Patients Alliance**

WAPO became a member in 2021 of WPA, a non-profit organization which is supporting patient organizations and patients, with a focus on all disorders.
